I (we) agree the FCPR holding this show or obedience trial has the right to refuse this entry for cause which the entity shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the show or obedience trial and of the opportunity to have the dog judge and to win prize money, ribbons or trophies, (we) agree to hold this entity, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or for injury which may be alleged to have been caused directly or indirectly to any person or thing by acts of this dog while in or upon the show or the obedience trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability or any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage, or injury be caused or alleged to be caused by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including death), sustained by any person of damage to property, arising out or in consequence of my (our) participation in this show or obedience trial, howsoever such injuries, death, or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties, or any of their employees or agents or any other persons.

I CERTIFY that I am the actual owner of the dog, or that I am duly authorized agent of the actual owner whose name I have entered above.
