# **Important Notice**

The Federación Canofila de Puerto Rico reserves the right to correct or revoke this application. Any misinterpretation in this application may be a cause for cancellation and result in losing all privileges with the Federación Canofila de Puerto Rico.

If this application is approved, the FCPR will send the owner of the litter the official individual registration of each puppy enrolled in the litter.

Once completed and delivered to the FCPR, this happens to be the property of the FCPR.

### The following instructions will guide you to complete the application.

- 1. The male and female must be enrolled in the Book of Origins of the FCPR on behalf of the person (s) who are or were owners at the date of crossing and delivery, before this application for registration is submitted to the FCPR. If the registration or transfer request of the male or female, included in it does not match the information provided, it will be returned.
- 2. To ensure proper registration of this litter, use uppercase letters on the marked lines. We're not responsible for bad interpretations. Errors may result in the cancellation of the application and will be required to submit a new application with a new payment.
- 3. Signatures: Where the signature of the owner of the male dog is required, and if it has a co-owner, with only one signature will suffice. Signatures of other persons or lessor, will be accepted by a notarized power or that a power has been previously authorized to the FCPR.

#### Remember:

Every breeder must register the complete litter indicating the name of each puppy. Effective february 1th 2019, It is compulsory that each puppy must have its own microchip

The following costs apply to the individual registration for each dog born in the litter.

(according to FCI regulations)

\$20.00 per puppy born in litter up to 3 months of age.

\$25.00 per puppy born in litter, 3 months 1 day to 6 months of age.

\$45.00 per puppy born in litter, 6 months 1 day to 9 months of age.

\$50.00 per puppy born in litter, 9 months 1 day up to 12 months of age.

\$175.00 per puppy born in litter over 12 months (1yr) old.

- It is the responsibility of the owner of the litter to give the name to each puppy in the application - No Partial Litter records valid.
  - The selected name will be officially registered. To apply for change of name, It must be accompanied by a letter and a fee of \$50.00
  - -This litter application must be accompanied by full payment, and will be returned by Regular postal mail from the United States.
